## Dive News:

### - **Fill Station Etiquette**

Please don't leave the Fill Station unattended until it is empty, locked, and shutdown.

I am fine if all divers are mobile around the GOT & Locker Room during filling as long as whoever puts the cylinder in takes charge in shutting down or designates someone to shutdown.

But do not leave cylinders charged and/or filling in the Fill Station if:

- Only the Standby Diver is available
- If the Team is going out to Lunch
- If no Diver is in the immediate vicinity to shutdown the Fill Station in the event of a failure.

Going back to your FSO Training, you are responsible for the whole building's safety from when you Put Cylinders in the Fill Station till when you take them out and Shutdown.

Remember we share that hallway with many Staff & Volunteers who don't know how to operate the Fill Station.

Do not rely on the only 2 FailSafe's to do the FSO's job.

### - **Surface Supply**

Just a follow-up. I haven't let this slip from my radar, unfortunately we prioritized other things ahead of Surface Supply Training.

I would like to thank everyone who completed the Quiz right from the get go and those who worked on it throughout our GOT shutdown.

Right now we're waiting to purchase Wetsuits/booties and organize storage before we start bringing Volunteers back into the other exhibits.

We unfortunately don't have a timeline yet but will keep you updated as it comes.

### - **Santa's Puff Ball & Safety Diver**

- **Bio Media from Filtration Room**

Below is a picture of the GOT's Bio Media from the Filtration Room's Bio Tower.

The Bio Tower plays a key role in stabilizing the GOT's water chemistry, by allowing good bacteria to anchor on its Bio Media.

When we reopened the pipes, this old media started breaking apart and drifting into the GOT.

**Fun Facts:**

- **GOT Pufferfish**

Our Pufferfish is officially called the Spot-fin Porcupinefish – *Diodon hystrix*

They have 2 flat teeth that are ever growing, like some rodents. This is to compensate for their naturally hard-shelled diet such as urchins, clams, or crabs.

This is a different method from how ray's maintain their teeth (which will be in next month's Newsletter)

In home aquariums, some pufferfish species have to get their teeth filed or clipped when there is no hard food diet available.
